## **Competition Regulations**

- The organizer of the competition is the Organizational Section of the Center for Foreign Languages of the PRz, Podkarpacka 1, 35-059 Rzeszów, in cooperation with the Department of International Cooperation International Cooperation Department, Powstańców Warszawy Avenue, 35-959 Rzeszów.
- 2. The subject of the competition is to give an original presentation in English on any topic chosen by the Competition Participant.
- 3. The Participants shall present an oral statement during the competition event on 19.05.2023 at 10:30 p.m. In case of unforeseen circumstances, the date may be subject to change.
- 4. POLITALKS Competition is aimed at students of Rzeszów University of Technology, who apply for participation in the Competition by filling in the form application form <a href="https://cjo.prz.edu.pl/studenci/zapisy-na-politalks/start.html">https://cjo.prz.edu.pl/studenci/zapisy-na-politalks/start.html</a> and sending a file containing a presentation lasting up to 5 minutes by 20.04.2023 to one of the organizers of the event: Katarzyna Kurek, MA (kkurek@prz.edu.pl), Małgorzata Doroszkiewicz, MA (mdoroszk@prz.edu.pl), Agnieszka Kozik MA (a.kozik@prz.edu.pl), Mateusz Szal PhD (mszal@prz.edu.pl)
- 5. No more than 8-10 people can participate in the Competition. In the case of a larger number of applications number of applications, the Organizer shall conduct preliminaries and inform about the list of candidates for presentation by e-mail no later than two weeks before the Contest.
- 6. The Competition will evaluate presentations on a topic chosen by the Participants, which will contain a punch line, a moral. The time to deliver a presentation per participant is about 5-6 mi Slides and other multimedia materials must relate to the topic of the presentation. The topic must be delivered entirely in English. It is prohibited to read from notes or have other aids teaching aids. Each Competition Participant will receive a microport and technical assistance on stage during the presentation.
- 7.
